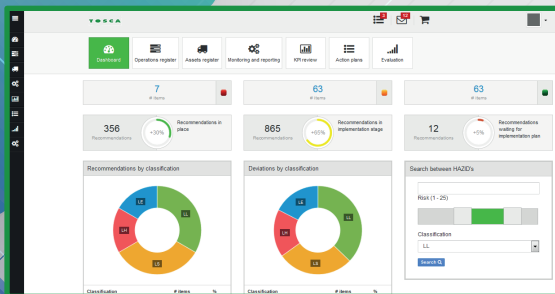

Besides, the monitoring of performance evaluation. And thus, guarantee corporate compliance, as well as legal & other requirements. 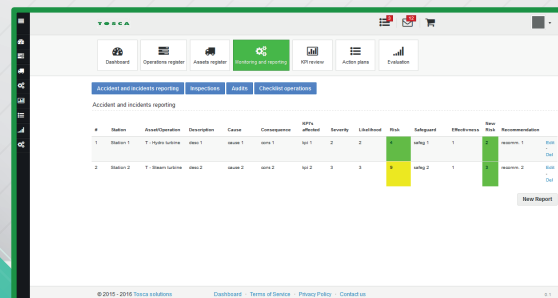


Benefits
